

MINUTES OF THE MEETING OF SELECTION COMMITTEE FOR ENGAGEMENT OF CONSULTANT TO STAFF THE PROGRAMME MANAGEMENT UNIT FOR ACCESSIBLE INDIA CAMPAIGN


The meeting of Selection Committee for engagement of consultants to staff the Programme Management Unit for Accessible India Campaign was held on 21st April, 2016 in the Chamber of Joint Secretary(MJ), 5th Floor, ParyavaranBhavan, C.G.O. 2. For engagement of consultants on contract basis for the two posts of i) Accessibility Expert/Consultant and ii) Social Media Consultant to staff the Programme Management Unit of Accessible India Campaign, applicants were called for interview on 21st April, 2016.

The Selection Committee decided to assess the suitability of the applicants by giving them marks out of 100 (20 Marks for Qualifications, 40 Marks for Experience in the related field and 40 Marks for performance in the interview), and bench mark of 60% was agreed to as minimum qualifying marks i.e. a minimum of 60 marks out of the total marks of 100 will be required to qualify. The Committee also decided to keep the qualifying candidate (securing minimum qualifying marks of 60%) in waiting list apart from the selected candidate.
