

MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 24th JAN, 2018 TO CONSIDER NEW PROJECT PROPOSALS UNDER THE DEENDAYAL DISABLED REHABILITATION SCHEME (DDRS)

A meeting of the Screening Committee was held on 24th Jan, 2018 under the Chairmanship of Dr. Prabodh Seth, Joint Secretary (DEPWD) to consider the proposals of NGOs received through State Governments for setting up new projects under Deendayal Disabled Rehabilitation Scheme (DDRS). Shri Bhushan Punani, Member of the Committee was present in the meeting. Shri Ashok Bhagat, member, could not attend the meeting.

2. The Screening Committee was informed that as per the detailed guidelines regarding streamlining the procedure for sanctioning of grant-in-aid issued vide this Department's letter No. 22-33(20)/2014-DD-II. Dated 16th July, 2014, the proposals duly considered and recommended by the State level Grant-in-aid Committee for supporting the voluntary organizations have to be considered by this Committee.

3. The Committee was informed that the new proposals received which are being screened and approved, may be considered for release of funds subject to receipt of recommendations/ proposals. The funds in these new cases recommended by the Committee are to be given from prospective effect only. The Committee agreed to the same.

4. A copy of the guidelines of the Scheme was provided to the Committee.

5. The Committee considered the proposals in the light of the recommendations of the State Grant-in-Aid Committee. The new project proposals were screened and approved provided they fulfill other requirements of the scheme and subject to submission of deficient documents if any, wherever it is necessary.

6. The Committee made the following general recommendations:

(i) It should be made obligatory upon all the organizations seeking grant-in-aid for running Special Schools, to submit a valid recognition/permission from concerned authority in the State Education Department and under PWD Act, 1995 and RPWD act, 2016. Further, their teaching staff should also conform to the requirements under the RCI Act.

(ii) As the Department had launched separate schemes for Skill Development and Awareness Generation, proposals under DDRS for these model projects may be submitted under the respective Schemes.

(iii) Processing of already recommended new cases in the previous and current meeting should be taken on priority on receipt of requisite documents & State Govt. Recommendations for the current year.

(iv) All the NGO's (Recommended/Deferred) are requested to be registered on NITI Aayog's NGO-Darpan portal.

(v) The NGOs(recommended or deferred) herein should be verified and checked with updated list of NGOs/voluntary organizations blacklisted/debarred/banned including from NE states by the Home Ministry and any other Department of Govt. of India and necessary action should be taken accordingly.

(vi) Recommendation of this Committee for proposals of the financial year 2016-17 will be valid till the end of financial year 2017-18 and those of the financial year 2017-18 will be valid till the end of financial year 2018-19.

(vii) Name of the project of proposal with Ack. No. UP/UP/00000410/08-16/20991 for the year 2016-17 may be change to "Project relating to Survey, Identification, Awareness and Sensitization". Since this project is not eligible under the revised scheme, the committee did not recommend the same.

(viii) The Committee has observed that no new cases will be processed without obtaining audited accounts of last two financial years.


8. In all, 63 new cases were examined and taken up for consideration by the Screening Committee of which :
