Under the Scheme, financial assistance can be given for various activities including setting up of a help line for online counseling of the PwDs, content development, publications and news media, organizing national events, participation in the international initiatives or to support various schemes organized by NGOs or self-help groups, volunteer service/outreach programme for sensitizing commercial establishment and employers, recreation and tourism, participation in community radio, press / media tours; support awareness campaign for skill development & employment generation for PwDs including job fairs; support spreading awareness about universal accessibility by creating an enabling and barrier-free environment that include accessible buildings, accessible transport, accessible websites and carrying out accessibility audit; promote individual excellence in the field of disability sector; Sporting and abilympics activities to promote talent and skill among PwDs which are to be supported through events, awareness campaign, etc.
